1. In addition to the Regulations in *Statutes and Ordinances of the University of Cambridge* which govern the Undergraduate Degree and in accordance with the Faculty of Divinity's Examination Archiving Policy, I agree that a copy of my dissertation (as entitled above) may be deposited in the Faculty of Divinity Library ('Faculty Library') for the following purposes:
 - 1.1 to archive and preserve the dissertation in any media in a secure permanent or portable storage/retrieval system for a period of up to five years, such period to commence on the date of award of my degree for which the dissertation was submitted and expire at the end of the calendar year of the fifth year after award, e.g. degree awarded at any date in 2010, expiry at the end of the calendar year 2015; and
 - 1.2 to provide the dissertation for the duration of the period in 1.1 for consultation by faculty, examiners, students and other authorized Faculty Library users of the Faculty Library on the following conditions:
 - a) authorised Faculty Library users may not take the dissertation out of Library premises;
 - b) authorised Faculty Library users may not copy the dissertation without the author's express permission. As author of the dissertation, I give consent for the Faculty Library (not a requestor directly) to contact me with any request made to copy the dissertation in whole or in part.
 2. With regard to any copy of my dissertation held at the Faculty Library, including in electronic/digital form, the University:
 - 2.1 may apply metadata elements or documentation to my dissertation;
 - 2.2 will exercise reasonable endeavours to preserve the physical integrity of my dissertation, but shall incur no liability for loss of or damage to my dissertation;
 - 2.3 if authorised to do so, shall not be under any obligation to reproduce, transmit, broadcast or display my dissertation in the same format in which it was originally created;
 - 2.4 shall not be under any obligation to take legal action on behalf of me or other copyright holders related to any rights in my dissertation;
 - 2.5 shall retain the right to remove my dissertation without notice for professional, administrative or legal reasons after its acceptance for archiving and consultation. Upon such an occurrence a listing and/or metadata record indicating that my dissertation had been held in the Faculty Library may remain visible in perpetuity; and

- 2.6 upon the expiry of the period in 1.1 shall destroy or delete (as appropriate) any copy of my dissertation held in the Faculty Library. Upon this occurrence a listing of my dissertation and/or metadata record indicating that my dissertation had been held in the Faculty Library may remain visible in perpetuity.

The information provided in this form is used for the administration of the deposit of Faculty of Divinity dissertations in the University of Cambridge Faculty of Divinity Library and is managed and stored in accordance with the UK Data Protection Act 1998 <http://www.admin.cam.ac.uk/univ/information/dpa/>. For data storage purposes, the University may store electronically the information outside the European Economic Area (EEA).
